

Free tax assistance will be available February 14 through April 18

All returns will be prepared by appointment only at the locations listed below. **NO WALK-INS. Masks are required for service.**

Gorge Tax-Aide offers senior-focused TCE service – with special attention to those aged 60 or older, and VITA service – with a focus on lower-income households.

Make an appointment, then:

1. Please print, complete and bring **Form 13614-C (October 2021) Department of the Treasury - Internal Revenue Service Intake/Interview & Quality Review Sheet (Rev. 10-2020)** or arrive 15 minutes early to pick up the form to complete before your appointment.
2. Include in your drop-off documents a copy of each person's driver's license(s) and social security card(s) for all parties on the tax return, i.e. taxpayers and dependents. These copies will be returned to you at the tax return review and submission appointment. Tax preparers also need your 2020 1040 tax return and page one of your 2019 tax return. Documents and/or tax returns not picked up within 14 days of the upcoming pick-up date will be securely shredded.
3. Organize and list your documents for the certified tax preparer's checklist. These categories are on Form 13614-C in parts III and IV. Your tax preparer will not calculate totals in any category, you must calculate all categories for example, medical expenses, charitable contributions both cash and in kind, and all others. If you have questions or concerns on how to handle this responsibility or any other, notify your tax preparer prior to your drop-off session via email.

APPOINTMENTS WILL BE SET ON A FIRST REQUEST BASIS

Important: All tax preparation will be handled on a drop-off basis only, including a very brief meeting with a certified tax preparer to begin the process, and a brief meeting to pick up and sign your consent for Tax-Aide to file the return electronically. All returns will be prepared by appointment only at the locations listed below. **NO WALK-INS. Masks are required for service.**

The AARP Tax-Aide program, administered by the AARP Foundation in cooperation with the IRS, provides free income tax assistance to ALL eligible taxpayers, with special attention to those aged 60 or older.

Volunteers will assist in preparing basic Federal and Oregon tax forms for personal tax returns. They can assist with most of your everyday tax situations including Affordable Care Act forms, Health Savings Account forms, filing for Earned Income Credit and Child Tax Credit.

However, volunteers cannot help you if you:

- Have a business with employees, inventory, net loss, or expenses over \$35,000 or have income from a hobby
- Want to file Married Filing Separately
- Have rental income from land with a structure
- Are filing a Part-Year Oregon Return (we file Non-resident and Full Year Resident Oregon returns only)

There are other complicated tax situations that may be beyond the scope of the AARP volunteers. If so, you may want to seek tax advice from a paid tax professional.

Tax returns are electronically filed as a free service by Tax-Aide.
